

PUBLIC CAMPING ON MALIBU ROAD?

As many of us already know, the Santa Monica Mountains Conservancy, headed by director Joe Edmiston, plans to build a number of new public camp sites located between Pacific Coast Highway and Malibu Road. The sites are to be in the hilly area adjacent to and above Malibu Road, roughly between house numbers 24616 and 24314.

Approximately 16 of these sites will be within 200 feet of the Malibu Road, several of them much closer. Moreover, the Conservancy intends to build a public parking area opposite the residence at 24608, and plans pedestrian crosswalks to existing beach accesses adjacent to 24752 and 24314 which, not incidentally, do *not* have Lifeguards. And it will undoubtedly result in more transient parking along the road.

Their plan includes many additional sites closer to PCH, as well as a paved parking lot across from John Tyler Drive. The circles with # 3 & 4 are proposed campsites, # 6: restroom, # 10: picnic area, # 11: parking lot (paved).

But arguably more important than any of the foregoing is the obvious, <u>very</u> real danger of fire. While the plans call for a prohibition of campfires, we have been informed by the Conservancy that because of insufficient funding there will be little or no supervision of campers with regard to smoking, nor cooking with flames, both of which pose an obvious and unacceptable risk in our fire-prone area.

While all of us believe that the lovely open areas of the Santa Monica Mountain are ideal for and should be enjoyed by all, we regard this intrusion into our quiet residential road truly objectionable and *unnecessary*.

Therefore, in an effort to prevent its being implemented in its present form and to help achieve the

best possible result for Malibu Road residents – for their safety as well as for the countless children who play in Bluffs Park, we have hired local attorney Greg Aftergood to serve as our advocate. Greg is working with the City of Malibu and the Santa Monica Mountains Conservancy to get the existing plan modified so that it works for all parties.

Which is why we are asking that *everyone* on Malibu Road join the **MRA**. This may be a protracted, very expensive fight, and we *need* those modest annual dues.
