## WET PAVEMENT <u>PROBLEM FIXED</u>

Thanks to the efforts of your Malibu Road Association, and the pressure it has exerted on the City of Malibu, the hazardous, permanently water-sogged-and-disintegrating section of Malibu Road surface just west of the Field of Dreams Beach is no longer wet.

Repairing the worsening condition that had existed for several years, a city-built temporary drainage ditch now carries the runoff from the bluff-residence(s) to the beach storm drain. The Road Association has been assured that a permanent concrete-lined drain will be constructed during the coming months, and that the pavement will be repaired.

## Think GREEN

The new Malibu Green Machine is a nonprofit, non-political organization of volunteers whose mission is to green public spaces in Malibu.

This group, spearheaded by community activist Jo Giese, has made its way through the many layers of bureaucracy to receive approval for a plan to beautify the Pacific Coast Highway median from Civic Center Way westward up to John Tyler Drive. The cost for this project is, astonishingly, over \$1 million. #### *FREE* EMERGENCY RESPONSE TRAINING COMING TO MALIBU

To prepare all of us to cope with the unexpected and/or disastrous, beginning in early November, the City of Malibu, together with the Los Angeles County Fire Department, will be offering no-cost C.E.R.T. (Community Emergency Response Team) training to the public.

These very worthwhile classes will be held on Saturdays, November 4, 11, 18, and Dec. 2 from 9am till 4pm (with a lunch break), at City Hall, 23815 Stuart Ranch Road.

C.E.R.T. classes include these modules: Disaster Preparedness, Fire Suppression, Disaster Medical Triage & Rescue, Disaster First Aid and Organization, Light Search And Rescue, Terrorism, Team Organization / Disaster Psychology and Disaster Simulation exercises.
