At Last! Trash Talk Success!

After years, countless meetings and negotiations with City and County authorities about The Trash Mess – and having to wait for the old contracts to expire until we could achieve change, victory is near! While the unsightly, ever-present containers won't vanish overnight, we're *finally* on our way to *major* improvements.

Because of pressure from the MRA Board, and backed by road-resident and City Council member Sharon Barovsky (and other parties), the contract being put forward for bids (to become effective in July 2008) stipulates the following:

- One day per week pick up of trash, green waste and recycling - a serious trafficpollution-noise reducing benefit. Those who will be inconvenienced by the single day pickup will be able to obtain more and/or larger containers.
- Optional "Roll-out" service, wherein your containers will be removed from, and returned to their enclosures. This will enable the City to finally enforce its laws about keeping trash containers concealed, leaving our beautiful road free of these eyesores.
- Provision of a lightweight truck for house-by-house pickup from bluffside residents at the west end of Malibu Road, thus eliminating the present ugly array of bins.

A big round of applause is due to our entire Board, and especially to our President, Bill Rhodes, for their persistent efforts.

MRA HELPS FUND MALIBU LABOR EXCHANGE

If you do see a dead seal or sea lion near your home, call the Labor Exchange (310.317.4717) and ask for someone there to bury the remains. The Road Association has trained the men and we pay for their time.
