MRA TO INSTALL 3rd SPEED SIGN!

Because our two solar-powered electronic speed signs are doing such an excellent job of reminding drivers to slow down and obey the 25 mph limit, your Road Association Board has voted to install a third sign, further west on Malibu Road. We're currently exploring possible sites for this new sign. As you may recall, the MRA paid for the first sign, and a very generous neighbor purchased the second one.

We will again be seeking the City's help with the permit/installation part of the process and we're asking for YOUR help to pay for this new sign. The total cost is about \$7000, and we welcome any contributions.

TRASH UPDATE

In case you've forgotten – though with all those containers in constant view that's hard to imagine – the City will soon begin negotiating a new trash-hauling contract. Your Road Association President Bill Rhodes will be on the negotiation committee and well-positioned to ensure that the new agreement meets all of our requirements.

Among the demands being stipulated by the MRA is that the contractor provide "valet" service, wherein someone from the hauling company will remove trash containers from their enclosures, place them at the fogline so that the trucks can empty them, and then return the containers to their enclosures. This service is a necessity in part because of the increased number of homes along the road that are not occupied full-time.

Once this new contract is in place, we will be asking the City to enforce the already-in-place regulations about keeping the containers out of sight, thus at long, long last eliminating this maddening eyesore.

DUES-R-DUE!

It's that time again. Many thanks to all of you who have joined our group and paid your dues – only \$100 for the year, and what a bargain! We provide speed signs, other signage, weekly road cleanup, advocacy/liaison with City, County and State, and a place for you to air your concerns and gripes. SEAL LION BIZ

There have been newspaper reports about more marine deaths due to the toxins in the algae - but luckily we have not seen an increase in dead seals and /or sea lions on the beach. If you spot a beached animal who needs to be rescued, please call 310.457.WILD.

If you do see a dead seal or sea lion near your home, call the Labor Exchange (310.317.4717) and ask for someone there to bury the remains. The Road Association has trained the men and we pay for their time.
